Mr. Pocock made a motion to approve the entire Consent Agenda as a group. Mrs. Zoni seconded. Motion passed unanimously on a voice vote.

2. Managers Memos

1. Appropriation \$716,500*Capital Fund - Farmington Canal Heritage Trail

Mr. Sciota explained that the Town applied for and was awarded the 100% grant to complete the Trail project.

Mrs. Zoni made a motion to appropriate \$716,500 for the Farmington Canal Heritage Trail. Mr. Morrison seconded. Motion passed unanimously on a voice vote.

2. Appropriation \$ 97,000 Snow & Ice - Program Supplies

Mr. Sciota stated that we have an expensive season not because of the size of the storms but the frequency of the freezing, which requires frequent treatments. The Snow & ice budget is holding up except for the need for additional product.

Mr. Morrison made a motion to appropriate \$97,000 for the Snow & Ice Program Supplies. Mrs. Zoni seconded. Motion passed unanimously on a voice vote.
